The per-team rate will be applied on a event-by-event basis, depending on whether the event is a league or tournament and whether the Officials feature is used.

For sports where a team consists of only one or two players, the per-team fee will be half of the rate quoted above. Schedules posted to Downloadable Files are subject to the same rates as schedules created by the QuickScores software.

Clients are subject to an annual minimum fee of \$200, which is paid upfront and placed as a credit on your account. As the site is used, the scheduling and online registration fees will be deducted from the \$200 credit. If the credits are exhausted within a year, invoices will be sent for each subsequent event. On the anniversary, the annual fee of \$200 will be due again, and any unused credits will be forfeited. Clients in good standing can be removed from this requirement at the discretion of QuickScores staff.

Leagues are billed approximately one week after the league begins. Tournaments are billed immediately after they begin.

Consulting

QuickScores provides free technical support for questions regarding use of the website software. Some clients desire a higher level of assistance in order to organize, setup and create league and tournament policies, schedules, and brackets. QuickScores will provide this type of consulting assistance at a rate of \$50.00 per hour, with a minimum of one hour. QuickScores will determine if and when simple technical support becomes a more involved consultation, and advise the client of such fees before beginning further consultation.

Online Registration Fees

QuickScores will charge the client a \$1.00 fee for every registration form submitted. QuickScores will invoice the client for these fees along with league/tournament scheduling fees when the event starts, or approximately every month for long-running registration events. The client will also be responsible for the processing fees charged by the payment processor (Clover, PayPal, Square, etc.) per their agreement with the processor.
